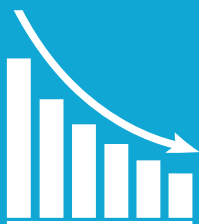
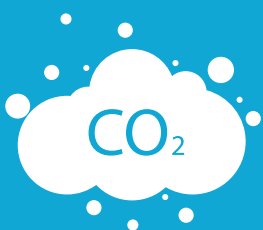
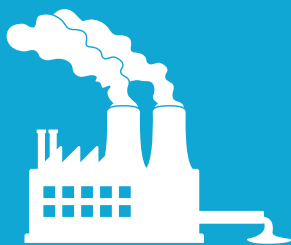


## CARBON FOOTPRINTING AND EMISSIONS REDUCTIONS

Organisations will therefore be required to account for their own emissions and to consider the supply chain emissions of the materials and services they use, including primary production, processing and manufacturing, transport, etc.
